1. Introduction

Welcome to **Listle Inc.** (“**Company**”, “**we**”, “**our**”, “**us**”)! As you have just clicked our Terms of Service, please pause, grab a cup of coffee and carefully read the following pages. It will take you approximately 20 minutes.

2. Communications

8. Refunds
